Workflow of Content From the Actiance Platform to Enterprise Vault

LDAP Integration

- The Actiance Platform imports users, groups, and attributes from LDAP directory
- Enables granular policies to be created

Export Using Journal Filtering

- Transcripts exported to a dedicated mailbox customizable headers
- Can export in XML, plain text, and HTML formats
- Transcripts sent from the remote or on-premise Actiance Platform

Archive Using Direct Connector

- Transcripts directly ingested into Enterprise Vault
- Transcripts sent from the on-premise Actiance Platform

Ingestion into Enterprise Vault

- Transcripts reach Enterprise Vault for long-term storage
- Transcripts can be tagged such that Enterprise Vault Discovery Accelerator categorizes them as "Instant Messaging" or "Social Networking"
- For organizations that have multiple Enterprise Vault Archives, transcripts can be captured centrally then exported to the appropriate regional archive
- The Actiance Platform maps users' buddynames and social networking accounts & identities to their respective corporate directory account names, enabling Enterprise Vault eDiscovery searches by email address, buddyname, or social networking account
