



**VERITAS OFFICIAL RULES FOR
ACCESS APPLIANCE SOCIAL SWEEPSTAKES DRAWING**

NO PURCHASE NECESSARY TO ENTER OR WIN. PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. NEED NOT BE PRESENT TO WIN.

BY PARTICIPATING IN THE DRAWING, YOU ACCEPT AND AGREE TO BE BOUND BY THESE OFFICIAL RULES AND DECISIONS OF THE SPONSOR RELATIVE TO THIS DRAWING.

1. SPONSOR

The Access Appliance Social Sweepstakes Drawing (the "Drawing") is sponsored by Veritas Technologies LLC (the "Sponsor"), 2625 Augustine Drive, Santa Clara, California, 95054, U.S.A. The Drawing begins on November 6, 2018, 10:00 AM PST and ends on November 20, 2018, 11:59 PM PST (the "Drawing Period").

2. ELIGIBILITY-VOID WHERE PROHIBITED

The Drawing is open to respondents who are: (i) able to download the Veritas Solutions application found at <https://m.kaon.com/c/ve> for installation on a supported device-type (PC/Windows, [iTunes/iOS](#) or Google Play/Android); and (ii) at least 18 years old as of November 6, 2018 and residing in the U.S.A. ("Participants"). Employees, officers, directors, agents, representatives, and immediate family members (defined as spouse or biological or step- mother, father, sister, brother, daughter, or son and each of their respective spouses), and household members of Sponsor, and its respective affiliates, subsidiaries, and agencies, are not eligible. 1. Download and install the Veritas Solutions application founds at <https://m.kaon.com/c/ve> a supported device-type (PC/Windows, iTunes/iOS or Google Play/Android);
2. Once the Veritas Solutions application is installed, navigate to the information for the Veritas Access Appliance. The animation screen for the Veritas Access Appliance should appear and you must click on the <AR> selection. Then, follow the application instructions to access an augmented reality view of the Access Appliance. Using the Veritas Solutions application, take a picture with the Access Appliance;
3. Share the picture that you have taken on Instagram and/or Twitter using #TrueSDS #AccessAppliance with a positive caption like "Exploring @veritastechllc #AccessAppliance. Check it out."; and
4. If you are selected as a winner, in order to complete your winning entry, you must provide your contact information (name, address and telephone and email) at which the Prize may be sent.

When you complete the above steps, you will be automatically entered into the Drawing. Multiple entries may be made by each person and each entry may be counted toward winning the Drawing. The total estimated retail value of each of the prizes to be awarded under the Drawing is US \$249. **Limit of One (1) Prize per person. AFFIDAVIT OF ELIGIBILITY AND WAIVER OF LIABILITY
